

Available as a cloud service, its popularity is already spawning across various verticals such as heavy industries, education, retail and FMCG. 'i-doc on Cloud' is our flagship product.

When i-doc is availed on cloud, it acts as a catalyst for better productivity and document collaboration, as this service resolves the issues related to huge expenditure on maintenance and security issues on the part of the client, while they use traditional VPN and LAN. The service helps in shifting from CAPEX to OPEX model.

Why a Document Management System?

All organizations have to resort significantly upon document oriented workflow on a daily basis. A lot of time is wasted in the process of searching and retrieval, especially in the case of hard format documents. Hard copies are often subjected to misplacement, destruction, lack of security and easy access to unwanted people. It reduces the expenses involved in making multiple replication of documents and shipping.

Deployment Model


We formulated two types of deployment models to fit the requirement of all types of organizations irrespective of its size.
